f. accelerating UNNES innovation; and

g. providing lectures with home lecturers at UNNES.

All expenses arising from the appointment of Adjunct Professors at Universitas Negeri Semarang are charged to the DPA Fund of Universitas Negeri Semarang in accordance with statutory provisions.

FOURTH

If adjustments are required or discrepancies are found, changes can be made in accordance with statutory provisions.

FIFTH

This decision shall take effect on the date of May 22, 2024 to May 31, 2027.
