MEMORANDUM OF UNDERSTANDING BETWEEN UNIVERSITAS NEGERI SEMARANG (UNNES), INDONESIA AND FREE STATE OF BAVARIA, REPRESENTED BY THE JULIUS MAXIMILIAN UNIVERSITY OF WÜRZBURG (JMU), GERMANY

The parties make this Memorandum of Understanding (MOU) in accordance with the Details and Terms.

Introduction

- A. THE JULIUS MAXIMILIAN UNIVERSITY OF WÜRZBURG, is a public research university in Würzburg, Germany. The University of Würzburg is one of the oldest institutions of higher learning in Germany, having been founded in 1402.
- B. UNIVERSITAS NEGERI SEMARANG (UNNES) is a public university in Indonesia, pioneer of excellence in education with conservation perspective.
- C. This MOU demonstrates and has the intention by UNIVERSITY OF WÜRZBURG and UNIVERSITAS NEGERI SEMARANG to negotiate a cooperative arrangement with the view to entering a separate agreement to carry out the specific collaborative activities under this MOU.

Proposed Activities

More specifically, the parties will discuss the following areas of mutual interest.

- A. To encourage and facilitate visits by the Departments from one University to the other for the purpose of engaging in studies, teaching and research or other educational activities (exchange of academic staff, administrative staff and students).
- B. To facilitate the admission of qualified students from one University to the other for the purpose of enrolling in undergraduate and graduate programmes, and in the case of advanced graduate students, participating in research. Tuition and fees, where applicable, will be paid directly to the student's home university based on the existing calculations made by each university. Each student will be responsible for his/her own transportation to and from the host University, as well as for room and board while attending the host University.
- C. To foster the exchange of academic publications and scholarly information; and



 To promote other academic activities which enhance the abovementioned goals.

Facilitation

For JULIUS MAXIMILIAN UNIVERSITY OF WÜRZBURG, the designated person is the Chancellor of the University of Würzburg and

For UNIVERSITAS NEGERI SEMARANG, the designated person is the Vice Rector of Partnership, Business and Internationalization of UNNES

1. Legal effect of this MOU

- 1.1 This MOU is not intended to be legally-binding and no legally-binding rights or obligations are intended to, or do, arise as consequences of the signing of this MOU.
- 1.2 Without in any way limiting clause 1.1, the parties acknowledge that by signing this MOU they do not agree, finalize or make any concluded terms or bargain and that no such concluded terms or bargain will exist between the parties unless and until a separate legally binding agreement is agreed and signed by them both.
- 1.3 Actions taken by either party in reliance on this MOU will be at that party's sole risk. Neither party shall be liable for any failure of or delay in performance of its obligations under this MOU.

2. Scope of co-operation

- 2.1 By entering into this MOU, the parties intend to promote a climate of open exchange and cooperation in an area of mutual interest in particular in the proposed activities set out in the details.
- 2.2 Matters of detail relating to specific cooperative activities, projects and other matters relating to the implementation of this MOU will, if appropriate, be negotiated and executed under a separate legally-binding agreement and any relevant supporting agreements.
- 2.3 Regarding intellectual property rights, this MOU only covers research and academic cooperation and does not cover the generation of intellectual properties. Specific programmes or projects undertaken pursuant to this MOU will be subject to separate regulation and agreement on intellectual property rights.

3. Separate legally-binding agreement

- 3.1 The condition for progressing from this MOU to a separate legally-binding agreement (if appropriate) included:
- (a) A documented evaluation and review of the relationship during the period of this MOU;
- (b) Demonstrated Mutual benefit to the parties;
- (c) Clear and defined objectives for the proposed formal relationship; and



(d) Negotiation and settlement of all the terms and conditions to be included in the separate legally – binding Agreement

4. Facilitation

The cooperation will be overseen by designated representatives of the parties set out in the Details.

5. Period of MOU

Both institutions agree to review this MoU after five years following the date of signing. It shall be automatically renewed for successive five-year periods unless either party gives the other written notice of its desire to either terminate or revise this MoU six month in advance.

6. Termination

Either Party may terminate this MOU in advance of the agreed upon termination date by providing written notice to the other Party at least 90 days in advance of the intended early termination date. Unless otherwise negotiated and agreed upon, students, faculty, and/or staff of either Party who are engaged in collaborative activities or exchanges at the intended time of early termination will be permitted to complete these activities or exchanges in accordance with the intention and spirit of this MOU.

7. Relationship

Nothing in this MOU creates an agency, partnership, joint venture or employment relationship between the parties or any of their respective officers, employees, contractors or agents.

8. Amendments

This MOU may be amended following discussions between the involved parties which may be followed by the submissions of an amended proposal with the intent of agreement and continuity. All such amendments shall be affected by an addendum to this MOU and other supplemental agreements signed by both parties.

9. Entire Understanding

This MOU constitute the entire agreement and understanding between the parties hereto and supersedes and replaces any and all prior or contemporaneous proposals, agreements, understandings, commitments or representations of any kind, whether written or oral, relating to the services to be provided hereunder or, inclosing any and all except the documents referred to in this MOU
