



## MEMORANDUM OF UNDERSTANDING

BETWEEN

**PHILIPPINE NORMAL UNIVERSITY, PHILIPPINES  
AND  
UNIVERSITAS NEGERI SEMARANG, INDONESIA**

Philippine Normal University, Philippines (PNU) and Universitas Negeri Semarang, Indonesia, agree to enter into a formal partnership agreement based on the foundation of mutual trust for the mutual benefit and development of the multi-party and the promotion of international understanding and goodwill.

- The two institutions resolve to exercise reasonable efforts to promote the following programs:
  - (1) Exchange of students.
  - (2) Exchange of faculty and researchers.
  - (3) Exchange of academic information and publications.
  - (4) Joint research activities.
  - (5) Joint organizers of international research conferences.
  - (6) Other exchanges of academic and cultural nature agreed upon by both parties.
- The implementation of various exchanges based on this agreement shall be separately negotiated and determined by a MOA-specific implementation program by both institutions.
- Nothing shall diminish the full autonomy of either institution or constraint on financial obligation imposed in carrying out the agreement.
- The agreement will remain in force for **five (5) years**. Any revision or renewal of the agreement is subject to mutual consent. It is also understood that either institution may terminate the agreement at any time, although such action will only be taken after mutual consultation to avoid any possible inconvenience to all parties.
- Should any intellectual property be generated from this undertaking, the rights and obligations of both parties shall be governed by RA No. 10055 otherwise known as The Technology Transfer Act. Should the parties, in the course of the activities under this MOU, generate personal data and other information, the same shall be governed by the provisions of the RA No. 10173 (Data Privacy Act of 2012).
- Disputes regarding the application of the provisions under this agreement will be resolved through any of the modes of alternative dispute resolution rather than through the traditional court system.
- This agreement is effective when the representatives of both institutions have signed and dated the document.
